

## Costume Plot: A Few Good Men

### Lt. Kaffee:

1) Naval khaki shirt (no epaulets), khaki pants, khaki belt with plain gold buckle, Naval lieutenant's insignia (double silver bar) on right collar, Judiciary corps insignia (see drawing below) on left collar, one or two ribbons above right breast pocket.

2) Naval white shirt (with board tabs), white pants, white belt with plain gold buckle, shoulder boards with insignia for lieutenant in Judiciary corps (see drawing below), service/visor hat with black cap device, officers' cap insignia and gold chin strap. Same ribbons as #1 above right breast pocket.

3) Navy Class A uniform black blouse (coat) with lieutenant rank and Judiciary corps insignia (see drawing below) on sleeve, black pants, white dress shirt, black tie, same cap as #2. Same ribbons as #1 above right breast pocket of blouse.

Note: You must have three identical sets of ribbons, there is no time to change them.

### Lt. Weinberg:

1) Naval khaki shirt (no epaulets), khaki pants, khaki belt with plain gold buckle, Naval lieutenant (double silver bar) on right collar, Judiciary corps insignia (see drawing below) on left collar, one or two ribbons above right breast pocket.

2) Naval white shirt (with board tabs), white pants, white belt with plain gold buckle, shoulder boards with insignia for lieutenant in Judiciary corps (see drawing below), service/visor hat with black cap device, officers' cap insignia and gold chin strap. Same ribbons as #1 above right breast pocket.

3) Navy Class A uniform black blouse (coat) with lieutenant rank and Judiciary corps insignia (see drawing below) on sleeve, black pants, white dress shirt, black tie, same cap as #2. Same ribbons as #1 above right breast pocket of blouse.

Note: You must have three identical sets of ribbons, there is no time to change them.

### Lt. Com. Joanne Galloway:

1) Naval khaki shirt (no epaulets), khaki skirt, khaki belt with plain gold buckle, Naval Lieutenant Commander's (double silver bar) on right collar, Judiciary corps insignia (see drawing below) on left collar, khaki combination ("bucket") hat with black cap device and officer's cap insignia, one or two ribbons above right breast pocket.

**Lt. Com. Joanne Galloway continued:**

2) (Optional) Naval white shirt (with board tabs), white skirt, white belt with plain gold buckle, shoulder boards with insignia for Lieutenant Commander in Judiciary corps (see drawing below), white combi-nation ("bucket") hat with black cap device, officers' cap insignia and gold chin strap. Same ribbons as #1 above right breast pocket.

3) Navy Class A uniform black blouse (coat) with Lieutenant Commander rank and Judiciary corps insignia (see drawing below) on sleeve, black skirt, white dress shirt, black cross-over tie, same cap as #2. Same ribbons\*\*\* as #1 above right breast pocket of blouse.

Note: You must have three identical sets of ribbons, there is no time to change them.

**Captain Whitaker:**

Naval khaki shirt (no epaulets), khaki pants, khaki belt with plain gold buckle, Naval Captain (silver bird) on right collar, Judiciary corps insignia (see drawing below) on left collar, eight ribbons above right breast pocket.

**Commander Stone:**

1) Two piece surgical scrub suit.

2) Navy Class A uniform black blouse (coat) with Commander's rank and Medical corps insignia (see drawing below) on sleeve, black pants, white dress shirt, black tie, eight ribbons above right breast pocket on blouse.

**Captain (Judge) Randolph:**

Navy Class A uniform black blouse (coat) with Captain's rank and Judiciary corps insignia (see drawing below), black pants, white dress shirt, black tie, thirteen ribbons above right breast pocket on blouse.

**Lt. Col. (may be full Colonel) Jessop:**

1) Marine utility (cammo-fatigues) shirt, pants, (belt optional - shirt is not tucked in), 2 Lieutenant Commander's insignia (black oak leaf) OR two Colonel's insignia (black bird) on both sides of shirt collar, combat boots, dog tags, undershirt.

2) Marine Class A uniform green blouse (coat) with belt, green pants, Marine tan shirt (with epaulets\*), tan tie, 2 black Marine insignia (see below) on collars, 2 Lieutenant Commander's insignia (silver oak leaf) OR two Colonel's insignia (silver bird) on blouse epaulets, same collar-size insignia on shirt collar; 2 Marksman medals (1 pistol, 1 rifle), 24 ribbons, all above right breast pocket of blouse, officer's service/visor cap with black Marine officer's cap insignia, gold chin strap and "scrambled eggs".

\* If actor does not remove blouse, use plain tan shirt.

**Captain Markinson:**

1) Marine fatigue shirt, fatigue pants. (belt optional - most wear the shirt out), 2 Captain's insignia (double black bar) on both sides of shirt collar, combat boots, dog tags, undershirt.

2) Marine dress Blue coat (officer's coat has black piping) with white collar piece, matching belt, light blue pants with red stripe, white gloves, service/visor hat with brass Marine officer's cap insignia (see below) gold chin strap and "scrambled eggs", 2 brass Marine insignia at collar, 2 Captain's insignia (double silver bar) on epaulets; 2 Marksman insignia, 14 Ribbons, all above right breast pocket.

**Lt. Ross:**

Marine Class A uniform green blouse (coat) with belt, green pants, Marine tan shirt (with epaulets\*), tan tie, 2 black Marine insignia (see below) on collars, 2 lieutenant insignia (single silver bar) on blouse epaulets, same collar size insignia on shirt collar; 1 Marksman insignia, 3 ribbons, above right breast pocket of blouse. If this character appears without blouse, ribbons and Marksman insignia must be above right breast pocket of shirt, and 2 full size lieutenant insignia on epaulets of shirt instead of collar insignia.

**Lt. Kendrick:**

1) Marine utility (cammo-fatigue) shirt, pants, (belt optional - shirt is not tucked in), 2 Lieutenant insignia (single black bar) on both sides of shirt collar, combat boots, dogtags, undershirt, field cap.

2) Marine Class A uniform green blouse (coat) with belt, green pants, Marine tan shirt (with epaulets\*), tan tie, 2 black Marine insignia (see below) on collars, 2 lieutenant insignia (single silver bar) on blouse epaulets, same collar-size insignia on shirt collar; 2 Marksman insignia, 8 ribbons above right breast pocket of blouse.

**Lance Cpl. Dawson:**

1) Marine utility (cammo-fatigue) shirt, pants, (belt optional - shirt is not tucked in), Lance Corporal black metal chevrons on both sides of shirt collar, combat boots, dogtags, undershirt, field cap.

2) Marine Class A uniform green blouse (coat) with belt, green pants, Marine tan shirt, tan tie, 2 black Marine insignia (see below) on collars, Lance Corporal chevrons on both sleeves of blouse (4" from shoulder seam); 1 Marksman insignia, 2-3 ribbons above right breast collar.

\*If actor does not remove blouse, use plain tan shirt.

**Pfc. Downey:**

1) Marine utility (cammo-fatigue) shirt, pants, (belt optional - shirt is not tucked in), Private First Class black metal chevrons on both sides of shirt collar, combat boots, dogtags, undershirt, field cap.

2) Marine Class A uniform green blouse (coat) with belt, green pants, tan shirt, tan tie, 2 black Marine insignia (see below) on collars, Private First Class chevrons on both sleeves of blouse (4" from shoulder seam); 1 Marksman insignia, 2 ribbons above right breast pocket on blouse.

**Cpl. Howard:**

1) Marine utility (cammo-fatigue) shirt, pants, (belt optional - shirt is not tucked in), Corporal black metal chevrons on both sides of shirt collar, combat boots, dogtags, undershirt, field cap.

2) Marine Class A uniform green blouse (coat) with belt, green pants, Marine tan shirt, tan tie, 2 black Marine insignia (see below) on collars, Corporal chevrons on both sleeves of blouse (4" from shoulder seam); 1 Marksman insignia, 4 ribbons above right breast pocket on blouse.

**Cpl. Dunn:**

1) Marine utility (cammo-fatigue) shirt, pants, (belt optional - shirt is not tucked in), Corporal black metal chevrons on both sides of shirt collar, combat boots, dogtags, undershirt, field cap.

2) Marine Class A uniform green blouse (coat) with belt, green pants, Marine tan shirt, tan tie, 2 black Marine insignia (see below) on collars, Corporal chevrons on both sleeves of blouse (4" from shoulder seam); 1 Marksman insignia, 4 ribbons above right breast pocket on blouse.

**Pvt. Santiago:**

Marine utility (cammo-fatigue) shirt, pants, (belt optional, shirt is not tucked in), combat boots, dogtags, undershirt, field cap.

**Sergeant at Arms:**

Marine Class A uniform green blouse (coat) with belt, green pants, Marine tan shirt, tan tie, 2 black Marine insignia (see below) on collars, Sergeant's chevrons on both sleeves of blouse (4" from shoulder seam); 1 Marksman insignia, 4 ribbons above right breast pocket on blouse.

**Military Police:**

Marine Class A uniform green blouse (coat) with belt, green pants, Marine tan shirt, tan tie, 2 black Marine insignia (see below) on collars, Sergeant's chevrons on both sleeves of blouse (4" from shoulder seam); 1 Marksman insignia, 4 ribbons above right breast pocket; green utility belt with holster, gun and ammo pack, service/visor hat with black Marine insignia and black chin strap (these are worn at all times). White on black M.P. arm band (left arm).



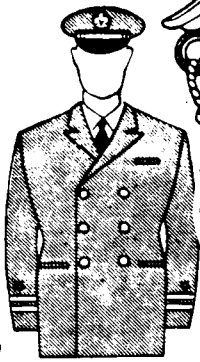
